**“Co-Parenting: Children in Changing Families”** Many divorcing parents experience a dilemma -- at the time their children are in most need of them, they are least emotionally available. This class helps parents focus on the needs of their children during and after a divorce. Parents will receive help in separating spousal issues from parenting issues. Topics include grieving the loss and moving on, how children react to conflict, active listening, and other strategies to help kids and parents cope with divorce and separation.

**Location:** All classes are currently being offered remotely on a secure video platform, called **Zoom**. Classes can be attended from the comfort of your own home, an electronic device capable of video and sound is required to attend. Participants are expected to fully participate in the entire course and should plan with their work and childcare, as needed. We also ask that participants are not driving and have their camera on the entire course to show engagement. If participants are unable to fully participate, they may be asked to retake the course, at the discretion of the group facilitator.
